Tax Cuts and Jobs Act Tax Reform Changes:

The new standard deductions are Single \$12,000, Married \$24,000 and Head of Household \$18,000. If you itemize, look at line 40 of your 1040, if that amount is lower than the new deduction, you may not itemize this year.

Home Mortgage Interest - You can still deduct the interest on your primary residence home loan. You can deduct interest on a second home if the loan was used to buy, build or improve the home.

Form 2106, Unreimbursed Employee Expenses, investment fees paid, and tax preparation fees can no longer be deducted on Schedule A.

Moving expenses can no longer be deducted except active duty military.

Child tax credit for dependents 16 or younger, is \$2,000 per child. You will receive a \$500 credit for all other dependents.

Health care penalty is still in affect for 2018 if you didn't have insurance.

Many owners of businesses may deduct 20% of their income as a credit. Entertainment expenses can no longer be deducted.
