**Tax Cuts and Jobs Act Tax Reform Changes:**

The 2019 standard deductions are Single \$12,200, Married \$24,400 and Head of Household \$18,350. Child tax credit for dependents 16 or younger, is \$2,000 per child. You will receive a \$500 credit for all other dependents.

Home Mortgage Interest - You can still deduct the interest on your primary residence home loan. You can deduct interest on a second mortgage if the loan was used to buy, build or improve the home.

Many owners of businesses may deduct 20% of their income as a credit called the Qualified Business Income Deduction (QBI). Entertainment expenses can no longer be deducted.
