**New Online Secure Drop Box Option and App for your phone**

Please email us for a link to upload your documents to our secure portal instead of sending your documents to our regular email address this year. Please email [frontdesk@jtaxes.net](mailto:frontdesk@jtaxes.net) with your name and email you would like to use and we will get you set up in the system. There is a new App (SecureFilePro) for your phone to use once you have set up an account. If you already have an account, you can just sign in.

**Tax changes/Updates**

**Business Mileage Rates:** Please give us 2 totals for mileage this year. One for January 1, 2022 - June 30, 2022 at \$0.585/mile. The other for July 1, 2022 - December 31, 2022 at \$0.625/mile.

**Some credits have expired on 12/31/2022, such as:**

- Child Tax Credit is now \$2000 per dependent under 16, \$500 per dependent over 16.
- Earned Income Credits have been lowered back to the 2019 amounts (pre-Covid), so expect lower refunds if you claim EIC.
- Dependent Care Benefits is now a \$2100 limit down from \$8000.
- There are no longer the \$300/\$600 Bonus Charitable deductions.

**Loveland**

Office hours are Monday thru Friday 9:30-5:30. Our secure Drop Box is available 24 hours a day. There is a bin in front of our office with envelopes and forms to use, if needed.

Once your taxes are prepared, we will email your documents to you, mail your documents back to you, or you may choose to pick them up.

**West Chester**

There is a 24 hour secure black Drop Box available to the left of the front door. Again, we will not have any pickups at this location.
